He has been engaged in several volunteer and leadership roles at Grand Harbor Golf & Beach Club and also participates in fundraising events in support of the Cleveland Clinic Indian River Hospital.

He has volunteered for the past five years and now serves as a Board Member of the Food Pantry of Indian River County. In this role he supports inventory management activities at the Pantry and the weekly procurement of food purchases from the Treasure Coast Food Bank. Dave also works with the Board in the development and promotion of a variety of fund-raising campaigns and food drives that support the ongoing distribution of food to residents in need here in Indian River County.

Jim has an extensive legal background in commercial real estate development working with major corporations internationally. His additional expertise in networking, organizational and strategic planning, and legal guidance in the various industries created added value to his work life. He and his wife, Josie, settled in Grand Harbor and quickly involved themselves in local non-profit work and have already made an impact in the community. His business acumen, organizational skills and creativity are a benefit to all, and his commitment will help raise awareness and funds for the Food Pantry of IRC create a stronger organization. Jim major concentration will be Major Donor Acquisition and Retention. Not only will he give his time to Fund Raising activities he along with Josie donate their time working at the Food Pantry.

#### PANTRY NEWS

In January, responding to the over 33% increase in food prices, the Board of Directors voted to increase monthly eligibility from once per month to twice. This action has resulted in a 35% increase in food distribution. Shortly after implementation we received news that The US Department of Agriculture was cutting one half a billion dollars (\$500,000,000) in assistance to Food Pantry's nationally. For us this means 25% less food that we received for free. We made an emergency appeal to the community and were able to, through the generosity of those who responded, maintain all existing programs.

This year we received a \$10,000 increase in funding from Head, Heart, and Hands, the Philanthropic Outreach of the Indian River Club to \$15,000. Grand Harbor Community Outreach provided an addition \$8,000.00 in funding for the Fresh Milk Program through their Strategic Fund. This was on top of their initial contribution of \$23,000, ensuring that the program is fully Funded. John's Island Community Service League awarded us a \$7500.00 grant to cover our first comprehensive audit. The Audit demonstrated our financial strength and reported that 91.7 cents of every donated dollar goes to program expenses. We are happy to annouce this year were awarded a Platinum Status by GuideStar Candid.

Our thanks to all who have helped us meet the challenges of 2025. We look forward to your continued support in 2026.

- 4 Green Onions Chopped, 1 stalk of celery sliced
- Dressing: ½ Cup Cider Vinegar, ¼ Cup Light Olive Oil, 1 Tbs Honey, 1/4 Tsp Garlic Powder, 1/4 Black Pepper, ¼ Tsp Onion (Optional)



Late this morning I served a man at the window of the food pantry who brought tears to my face after he walked away. The first time that's ever happened to me while working there. I know for sure what the food pantry does here in Vero Beach is extra special.

The gentleman was an African American with an artificial leg. He pushed a wheelchair and told me it's like his cane.

He arrived by bus. Some of you may know him.

As we talked I learned he lives with and takes care of his elderly parents. He showed me his hands and fingers which were bent because of a stroke. I asked how he would get his food, milk, bread and meats home. He replied by the grace of God, my wheelchair and the bus. I should not worry. I took the food out of the normal packed box and provided two canvas bags. We traded cans for items not as heavy. He asked for some apple juice or whatever we have as he was thirsty. Throughout the 5 or so minutes we interacted he must have thanked me 10-15 times and kept saying "bless you". He had on a baseball cap with the word Jesus across the top. He pointed to it and told me he helps me...

What an incredible human being. Positive, gracious and kind. Not a negative word from his mouth, just appreciative and genuinely thankful. No complaining or blaming others. As he walked away pushing his wheelchair with the two bags of food in the seat I knew we did something good today.
